Wednesday, August 7, 2013

Antoine Jamal Heath, 25 (DOB 5/23/88), of Detroit, has been charged by Prosecutor Kym L. Worthy in connection with the homicide of Ivan Clark Murad, 25, of Clinton Township. On April 16, 2013, at 3:17 a.m., police EMS responded to a call in front of home located in the 18600 block of Fairway in Detroit and observed Murad with multiple gunshot wounds. He was pronounced dead on the scene.

Heath has been charged with First Degree Murder, Felon in Possession of a Firearm and Felony Firearm Second Degree. He was arraigned today in 36th District Court. The preliminary exam is scheduled for August 19, 2013 at 1:30 p.m.

Grosse Pointe Shores Councilman Charged with Domestic Violence

Prosecutor Kym L. Worthy has charged Grosse Pointe Shores Councilman Daniel Thomas Schulte, 59 (DOB 1/17/54), in connection with an alleged domestic violence assault involving his wife that occurred on August 7, 2013, at approximately 10:22 p.m. The Grosse Pointe Shores Police Department received a 911 call to the marital residence on Hampton Street. Officers interviewed the victim and another family member at the scene. As a result, Schulte was placed under arrest.

He has been charged with Resisting and Obstructing (two years), Preventing a Crime Report (one year) and Domestic Violence (93 days). We were informed this morning that Schulte was arraigned during the evening of Thursday, August, 8, 2013. His preliminary examination is scheduled for August 21, 2013. The local judge has disqualified himself; the State Court Administrator will be assigning another Judge to the case. Please contact the police for a photograph of the defendant.

Two Detroit Men Charged with Impersonating Officers During Robbery

Prosecutor Kym L. Worthy has charged Derrick Williams 28 (DOB 2/23/85), and Bryce Hendricks, 24 (DOB 1/27/89) in connection with a robbery that occurred on August 4, 2013, at 1:45 a.m. at Edgevale and John R. in Detroit. They allegedly claimed to be "Fugitive Recovery Agents" when they approached two males ages 32 and 37 of Detroit. The defendants are alleged to have announced that they were the police and detained the victims taking their cash.

They are charged with two counts each of Armed Robbery, Unlawful Imprisonment, Impersonating an Officer and Felony Firearm. Defendant Hendricks is charged with Felon in Possession of a Firearm.

They are expected to be arraigned today at 1:00 p.m. in 36th District Court. Please contact the police for photographs of the defendants.

Detroit Man Charged in Second Murder Case

Antoine Jamal Heath, 25 (DOB 5/23/88), of Detroit, has been charged by Prosecutor Kym L. Worthy in connection with a second homicide case. Victim John Victor Cuciurean, 43, of Detroit was found dead in the early morning hours of April 13, 2013, in the 3800 block of Crane. He was alleged to have been fatally shot by Heath. The details of the case will be presented in court. Heath is expected to be arraigned on Saturday, August 10, 2013 in 36th District Court.
