Renisha McBride Case - The Wayne County Prosecutor's Office is waiting for several items relating to the investigation from the Dearborn Heights Police Department at this time. We have begun the warrant review process. News will be released when a charging decision has been made.

Tuesday, November 12, 2013

Jerrel Files - Detroit defendant charged with the homicide of Checker Cab driver Michael Uche on Goulburn Street. The case was up for trial today in Judge Lawrence Talon's courtroom. Two necessary witnesses failed to appear and the case was dismissed today, November 12, 2013. The warrant has been re-issued and the date for the arraignment will be released when we have the information. Files remains in custody. Please refer to the attached case update for the charges in the case.

Reneco Graus – Defendant charged in connection with a fatal arson fire in a Highland Park Apartment Building, was bound over today in 30th District Court on all charges. Please refer to the attached case update for the charges in the case. Her arraignment on the information will be held on November 19, 2013. Graus remains in custody without bond.

Michael Booker - Defendant charged with crimes in connection with WSU Law Student Tiane Brown. Booker had a preliminary examination today and was bound over as charged. His arraignment on the information will be held on November 19, 2013. Booker remains in custody on a \$500,000 cash/surety bond. Please refer to the attached case update for the charges in the case.

Renisha McBride Case - The Wayne County Prosecutor's Office has now received the additional investigation from the Dearborn Heights Police Department. The warrant review process is continuing. News will be released when a charging decision has been made.

Thursday, November 14, 2013

Robert Windsor – Defendant charged with a crime in connection with Wayne State University law student Tiane Brown. The misdemeanor charge of Receiving and Concealing Property under \$1000 was dismissed today in 36th District Court because the alleged criminal activity regarding this defendant occurred in Highland Park and not Detroit. The warrant will be re-issued today in 31st District Court in Highland Park.
