Tuesday, February 18, 2014

Larry Paul Johnson, Rashawn Tyrell Johnson, Keeshon Lorenzo Lake & Tenisha Shavell Jackson- Four defendants each charged with First Degree Premeditated Murder, Felony Murder, two counts of Armed Robbery and First Degree Arson in connection with the February 10, 2014 homicides of a father, his son and another male that were discovered during an arson fire of a house located in the 13000 block of Bentler. The Preliminary Examination in the case will be held on Thursday, February 20, 2014 at 1:30 p.m. before Judge Jones-Coleman.

Robert Bashara - Grosse Pointe man charged in the death of his wife Jane Bashara. Today Judge Vonda Evans removed the defense attorneys representing Bashara. She appointed two new attorneys and will announce the appointment of a third attorney at the next court date on March 11, 2014.

Thursday, February 20, 2014

Sandra St. Andre – Wife of former Romulus Police Chief charged in the Romulus Police Department corruption scandal. She was sentenced today on the following charges: Continuing Criminal Enterprise - seven to 20 years, Continuing Criminal Enterprise - seven to 20 years, Filing Fraudulent Tax Returns - two to five years and Receiving and Concealing Stolen Property - two to ten years. All sentences are concurrent. Restitution will be determined at a later date.

Patricia Johnson, Robert Richardson and Harvey Witcher - Charged in the fatal shooting death of a four-year-old boy in Detroit. Johnson, Richardson and Witcher are scheduled for arraignment on the information on Friday, February 21, 2014 at 9:00 a.m. before Judge Qiana Lillard.

Joseph Weekley – Detroit Officer charged in connection with the death of Aiyana Stanley-Brown, who was fatally shot during a police raid. The judge is not available on the originally scheduled date of February 28, 2014. A new date has not been announced by the court at this time.
