## **NEWS UPDATES**

### **Monday, January 12, 2015**

Erin Justice – Detroit man charged with the homicide of his wife, Alicia Marie Fox. Justice was scheduled for a competency hearing tomorrow before Judge Ruth Carter. Due to the changes at 36<sup>th</sup> District Court, the case has been reassigned to Judge Shannon Holmes.

On November 6, 2014, the defendant was referred for competence to stand trial and criminal responsibility. The Forensic Center has not completed the final reports and the case has been adjourned. The court has not set a new court date at this time. An update will be sent out with the new date when it is received.

### **Tuesday, January 13, 2014**

Terrill Hardaway – Detroit Firefighter convicted in the fatal shooting of a disc jockey in December 2012. On Monday January 12, 2014, he was sentenced before Judge Daniel Hathaway for three-15 years on the Manslaughter charge and two years consecutive for the Felony Firearm charge. Motion for bond pending appeal was denied and he began his sentence yesterday. The defendant's Motion for New Trial will be heard on January 22, 2015 at 1:30 p.m.

Alonzo Long Jr. – Defendant charged with the shooting deaths of a homeowner and his daughter at a home located on Piedmont in Detroit. Today the defendant was Arraigned on the Information before Judge Dalton Roberson, who is standing in for Judge Alexis Glendering this week. The

Final Conference date is scheduled for March 3, 2015 at 9:00 and the trial date is scheduled for April 20, 2015.

Drequone Lamar Rich – One of the three adult defendants charged in the homicide of French street artist Bilal Berreni. Today his preliminary examination was continued before Judge Michael Wagner and he was bound over as charged. Defendants Jasin Curtis, Dionte Travis and Drequone Rich will be Arraigned on the Information before Judge Bruce Morrow on January 16, 2014 at 9:00 a.m.

Cory Ivan Rimson and Victoria Foster – Defendants charged in connection with the death of Defendant Foster's seven-year-old son. Today the preliminary examination was adjourned. Judge Shannon Holmes granted an adjournment because the medical examiner had not completed the autopsy report. The report is expected at the end of the week. The new date for the preliminary examination is February 5, 2015 at 1:30 p.m.

### **Wednesday, January 14, 2015**

Robert Bashara Sentence Hearing – Grosse Pointe Park man convicted of killing his wife Jane Bashara. His sentence hearing is scheduled for Thursday, January 15, 2015 at 9:00 a.m. before Judge Vonda Evans.

Marcus Weldon – Defendant dressed as Santa charged in the Speedway gas station shooting of two men. The defendant was bound over today on all counts. The arraignment on the information is scheduled for January 29, 2015 at 9:00 a.m.
