State Senator Virgil Smith - The Wayne County Prosecutor's Office has recently received the returned warrant request from the Detroit Police Department and it is currently being reviewed. An update will be sent out when a charging decision has been made.

UPDATE: Smith was arraigned in 36th District Court today and received a \$25,000/10% bond. His probable cause hearing will be held on May 22, 2015 and his preliminary examination will be held on May 29, 2015.
