### **Monday, February 1, 2016**

Robert Bashara – WCPO was informed by Judge Vonda Evans this afternoon that she will hear a Motion to Unseal the Bashara court file on Tuesday, February 2, 2016 at noon.

Daraian Winfield – Today the defendant was bound over in the Grosse Pointe Park case where he is charged with Assault with Intent to Murder in connection with an assault of a Grosse Pointe Farms woman. He will have his arraignment on the information in Wayne County Third Circuit Court Criminal Division on February 8, 2016 at 9:00 a.m.

Eastland Mall Homicide – The continued preliminary examination for the three defendants in this matter - Brendon Stanton-Lipscomb, Demetrius Armour and Tyshon Taylor - has been rescheduled from February 2, 2016 to February 16, 2016 at 10:00 a.m. in District Court 32-A before Judge Daniel S. Palmer in Harper Woods.

### **Tuesday, February 2, 2016**

Robert Bashara – Today Judge Vonda Evans granted a Motion to Unseal the Bashara court file. The next court date is the defendant's post-conviction motion that the court has rescheduled from February 11, 2016 until March 11, 2016 at 9:00 a.m.

William Melendez – Former Inkster police officer convicted in the assault of Floyd Dent. Today Melendez was sentenced to 13 months to 10 years for the Assault with Intent to Do Great Bodily Harm and 90 days, with credit for time served, for Misconduct in Office.

Virgil Smith – State senator charged in a non-fatal shooting incident involving his ex-wife on Wexford Street in Detroit. The final conference before Judge Larry Talon has been adjourned from February 5, 2016 until February 11, 2016 at 8:30 a.m.

**Charges Issued in Kajavia Globe Homicide**

Today Prosecutor Kym L. Worthy has charged Maxwell Brack, 24 (DOB: 6/28/91), of Detroit, with Open Murder, which carries a maximum penalty of life in prison without parole. On December 11, 2015, Kajavia Globe, 24, of Detroit, was reported missing by her family. On December 14, 2015, the Detroit Police Department discovered the victim's lifeless body in a trash container in the rear of a location in the 18500 block of Fielding Street in Detroit. Investigation by the Detroit Police Department identified Brack as the alleged murderer of Ms. Globe. Brack was arrested in connection with the homicide on Friday, February 5, 2016.

Brack was arraigned today and remanded to jail. His probable cause conference is in February 12, 2016 at 8:30 a.m. and his preliminary examination is on February 19, 2016 at 9:00 a.m.
