#### START AREA:

Merriman Hollow Park is located on Hines Drive, off Merriman Road between Ann Arbor Trail and Warren Avenue in Westland.

#### FINISH LINE:

Warrendale Park is located on Warren Avenue, east of Telegraph in Dearborn Heights.

**Start Area and Check in:** Location is Hines Park-Merriman Hollow Area, which is the entrance to the Lightfest (7651 Merriman Road in Westland). Hines Drive will be closed to non-race traffic. **Check in begins at 5:30 p.m. and ends at 6:45 p.m. The event starts at 7:00 p.m.**

Since the start and finish of the event are in two different locations, please arrive early and follow one of the alternatives:

1. **Park at the start area at Merriman Hollow and take the shuttle bus back to your car after the event.** Parks staff will direct you where to park your car.
2. **Have family or friends drop you off at the start area.** They can park at the finish and cheer you on your arrival. From Merriman Hollow Area, turn right on Merriman Road, turn left on Warren, follow Warren past Telegraph and turn left into Warrendale Park. **Please note that there is minimal parking at Warrendale this year!**

Lightfest features more than 47 giant animated displays and more than one million lights; it is the Midwest's largest and longest light show. The complete Lightfest route is over four miles of Hines Drive.
